Old Business: CNC/Laser/Plasma Cutter

Change guideline to read:

“Items produced by CNC, laser, plasma cutter, or any “subtractive manufacturing” must be of original design of the Member. They may not be facsimiles of any other object. Any file used must also be the sole work of the Member. Additional handwork of an artistic nature must be part of the production process. CNC, laser cutter, or plasma cutter objects must come to a full Standards Committee meeting.”

Add: “You may use a graphics program to design your art, but all artwork must be of you own original design. The original design may be scanned into your graphics program.”
