**CBD Requirements** 

- 1. Hemp CBD only. No Marijuana/THC CBD.
- 2. You must provide The Saturday Market with the name and receipts from the licensed manufacturer that you buy your hemp CBD from.
- 3. Product labeling must contain the name of the licensed CBD manufacturer and country of origin.
- 4. Products must meet all standards and guidelines required for the product being sold.
- 5. If your CBD product is an ingestible, (taken orally,) you will be required to provide to The Saturday Market a copy of: a commercial kitchen license in your name; proof of liability insurance; and food handler's card. All guidelines pertaining to prepackaged foods must be met.
- 6. Absolutely no medical claims can be made.
- 7. All CBD products must be screened at a full Standards Committee meeting, not a regular product screening.

Motion to change language: Prepackaged foods sold in a craft booth are intended to be a single category item, packaged for offsite consumption.
