From The OfficeGood Morning Saturday Marketers!

Saturday is the best day of the week. All of us work all week long to make it to Market on this day. Every Saturday that we can get together on the Park Blocks is a joy. Thank you so much to all of you that came out to make a Market today.

We understand that there is a lot of confusion and trepidation surrounding our Holiday Market plans. It's a crazy time to make future plans. This dastardly pandemic keeps getting in the way, and it's hard to know what to do about it. Please feel reassured that your Board and your staff are making careful, researched decisions on your behalf.

We are looking good to have the Holiday Market at the Lane Events Center. We did a site survey this week, and we also have been given support from the LEC staff regarding safety measures that cover a range of scenarios. The LEC is working with us regarding our contract and payment schedule. Our contract states that if we must cancel our event due to a government mandate, then they will hold over any funds they have received until 2022. We let our members know last month that any funds we have paid to the LEC will not be refunded and would instead be applied towards 2022. They have agreed to delay payments in light of the current situation so at this time, no money has been paid to the LEC. Our final date to cancel our plans is October 15th. At this time, we are expected to make a downpayment that is non-refundable by September 30th with the final payment due on October 15th. We have asked to waive the deposit and instead make one full payment on October 15th. If they agree, then our final date to change course is October 15th. In the event that no money is given to the LEC, all Holiday Market funds will be returned to members.

Now, with this date in mind, we can switch our plans to an outdoor Holiday Market if the pandemic is still keeping us from moving inside. We have the time and the plan in place to switch our direction as of this date. We hear that the city will be lighting up the trees this year too!

What you can all do today is mask up, wash those hands and maintain space. The sooner we get this surge under control, the better we can plan for our wonderful indoor Holiday Market.

Downtown Developments Task Force

About ten of us met yesterday and figured out a few things we need to know about the project. We'd like to see more detailed maps, to know if there are bike lanes on both sides, and just how the removal of the curbs will look for loading. We'd like clarification of the closing of Oak, to know if we can still use it for loading. We figure 20-40 booths will be directly impacted, so we can fit those on the perimeter of Park streets, if we will have access to Park Streets from Oak and can make a workable traffic

We want the Market to open as usual in April, but as it will be severely impacted in many ways during the whole season-long project, we plan to negotiate for some accommodation from the city such as waived rent and street closure fees. We may want to use Broadway or Kesey for some booths, or to aid the traffic pattern during loading. We could also consider relocating to Broadway or even to 5th St, or using some of the LCFM site if they have room. We may need to have some type of scheduled and staffed

We'd also like to adjust our permit to use some of the grass areas for booths, using plywood or mats to protect the lawns. It would be best not to eliminate the 4x4 option altogether, but maybe some of them could also be relocated to allow 8x8's along the south sidewalk, since being up out of the street will be better for booths if it rains. We will be taking a look at the Market footprint to see what creative ways we can fit the displaced booths. It's possible to offer an extra vacation month to people who would rather not sell, or use an even/odd arrangement to work with the displacement. There are still so many unknowns with Covid and the scheduling of the project that we want to have plans in place that can be flexible for use when needed.

City projects are routinely rearranged and re-scheduled, so we may ask that we be scheduled last instead of first or otherwise accommodated so that we can sell as usual. After two years of compromised seasons, our members want to be able to sell. The farmers will want us there, as well as the surrounding businesses.

Next steps will include communicating with the project manager to get some of our questions answered, sketching out some options, and continuing to analyze and communicate the plan to our members so we can gather all the best ideas. Please let me know if you think we haven't thought of things that might be useful.

We didn't set another meeting date but will plan to meet when we have new information. Take a look around on Saturday and see if you can imagine how it might work without using 8th at all...the specifics are going to be important. Thanks to all who have participated and shown interest.

The uncertain nature of the Covid-19 virus has shaken all of us when it comes to making plans. After speaking with the Lane Events Center and doing some research, we feel confident about moving forward with our plans for an indoor Holiday Market.

Keep in mind that we are still watching the case count closely and monitoring for updates from the state and local government daily. We will make our Holiday Market plans with safety as the priority.

We are booking at 49 Points!

Please have a map handy and keep your eyes on your phone for a call from AJ to book your space.

We will have the Work Task sign up sheets a the Info Booth starting September 11th. You can call the office during the week to sign up for a Work Task if you are unable to make it to the Market.

We will send out Holiday Market statements in the middle of September, October and November with payments due at the end of the month. Payments are due September 30th, October 30th, November 30th. As usual, all balances must be paid in full by December 24th including Saturday Market fees.

The final deadline to cancel your Holiday Market booking for a full refund is October 15th. If you cancel after this date, then you will not receive a refund unless we can rebook your space.

Booth share forms will be ready the week of October 19th. This year, only members that share a household can share a booth unless both members are vaccinated.

Labor Day - Office Closed

The Saturday Market office will be closed on **Tuesday, September 7**th to observe Labor Day. We will be back in the office on Wednesday, September 8th from 10am-4pm.

Tuesday Market Announcement

Anyone that would like to sell at Tuesday Market must declare attendance by Thursday at 4pm the prior week. If we don't have any declarations, then we will not be available on Tuesday morning on the East block to hand out envelopes. Also, if you declare then do not show up, you will be held responsible for the \$5 booth fee.

We did not have anyone declare attendance for Tuesday, September 7th. JJ will not be available to hand out envelopes if a member decides to sell that morning.
