## **Pressing Member Concerns:**

under the Craft and Market Guidelines. In summary, this committee
member wanted to formulate a way to handle this process if it were to
ever happen again.

In conclusion, as a Standards Committee member instead of letting the market vendor know on the spot of the violation, we can alert the market staff to fill out a 'notice of concern' along with a rate of urgency, of how pressing the violation is. Therefore, moving forward, the market staff will give out notices of concern either on the day of discovery or in the future days.

- Market staff want to emphasize encouraging current and future market members to purchase single memberships over joint memberships to prevent issues down the road with points and other business issues.
- A niece of a current market member has reached out to the Standards Committee requesting if she, the niece, can sell her aunt's (market member) crafts at the market, since her aunt has fallen ill. In this specific case, the Standards Committee may allow an exception to the standard "the maker is the seller, or living in the same economic unit" because of the current circumstances for this particular market member. The two of them will need to write up their circumstances and present it for this exception to pass.
