### **Pressing Member Concerns:**

**Wild Coast Brewing:** From Coos Bay a husband and wife have locally sourced teas. The cannisters have beautiful art on them which was created by a third party creating a packaging issue. Would people just buy the cannisters without considering the tea? The artist wanted to sell a calendar with just the artwork on it. The calendar was a no go. The cannisters could be used after the tea was gone. The committee approved his product for the Holiday 2023 season. This product would need to be looked at again in the spring 2024 when the artist will be encouraged to sell his tea in the compostable plastic bags that are on his web site. Discussion ensued about the parameters of artwork on pre-packaged goods.

**Wooden Lyre Artist** with music books: This artist put together a music book years ago that would help people learn how to play the lyres she makes. The books are composed of songs and clip art which make a nice composition. The music and clip art are not her work. It was decided that the music book could be given with the purchase of every Lyre but could not be sold alone.

**Dinosaur Nugget 3D Jewelry**: The artist drew a picture of the dinosaur then handed it to a person with a 3D printer to make the 3-piece jewelry set. She was denied acceptance to sell at HM as she did not produce the 3D pieces.

# Review requirements for use of commercial patterns/digital files... CNC/ Laser/Plasma Cutting:

Don led the discussion about the difference between a file and a program. There is a difference. The file is where the original art is stored. The program is how the original art is applied to the tool.

**Motion:** THE MEMBER DOES AN ORIGINAL DRAWING, scans it, uses that file in the graphic program that drives the CNC/laser/plasma cutter software. Anna/Willy 7-0-0
